**ORDER**

- (1) By Certificate of Referral dated 12<sup>th</sup> February, 2019 the Minister referred the subject dispute to the Industrial Tribunal; and
- (2) In accordance with Rule 3 (1) of the Industrial Relations (Tribunal Procedure) Rules, 2010 a Notice for an Originating Application – Form A was sent on 4<sup>th</sup> April, 2019 by the Secretary, to the Tribunal, to the Applicant; and
- (3) Upon receipt by the Applicant of the Notice for an Originating Application the Applicant filed an Originating Application in the Tribunal on 10<sup>th</sup> April, 2019; and
- (4) A Notice of Application to the Respondent – Form C and a Notice of Appearance - Form D was sent to the Respondent on the 30<sup>th</sup> April, 2019; and

- (5) That a Notice of Appearance - Form D was filed on 7<sup>th</sup> May, 2019 and a Defence - Form E was filed on 29<sup>th</sup> May, 2019 in the Tribunal by the Respondent; and
- (6) Pursuant to Rule 15(1) of the Industrial Relations (Tribunal Procedure) Rules 2010, the Industrial Tribunal set a fixture for the Case Management Hearing for Directions on the 8<sup>th</sup> July, 2019; and
- (7) On the day of the Case Management the parties appeared and the matter was adjourned to allow the parties to have discussions; and
- (8) The parties informed the Tribunal that the matter has been settled; and
- (9) The Respondent without admitting any liability to the Applicant whatsoever has agreed to pay the Applicant Five Hundred Dollars (\$500.00) as final payment; and
- (10) On the 1<sup>st</sup> August, 2019 the Applicant filed into the Industrial Tribunal a Notice of Withdrawal - Form K.

**THE DECISION OF THE TRIBUNAL IS AS AGREED AND THEREFORE IT IS SO ORDERED:**

- (11) The Originating Application filed in the Industrial Tribunal on 10<sup>th</sup> April, 2019 is decided accordingly pursuant to Rule 12(1)(b) of the Industrial Relations (Tribunal Procedures) Rule 2010 and is hereby marked Settled.
