ORDER ON DIRECTIONS

WHEREAS:

- 1) By Certificate of Referral of a Trade Dispute dated 24th October 2018, the Minister referred the subject dispute to the Industrial Tribunal;
- 2) Pursuant to Rule 3(1) of the Industrial Relations (Tribunal Procedure) Rules, 2010 a Notice for presentation of an Originating Application was issued by the Secretary of the Industrial Tribunal to the Applicant on 3rd January 2019;

- 3) The Applicant filed an Originating Application (Form A) in the Industrial Tribunal on 14th February 2019;
- 4) Pursuant to Rule 4 of the Industrial Relations (Tribunal Procedure) Rules, 2010 a Notice of the Originating Application (Form C) was issued by the Tribunal to the Respondent on 1st March 2019;
- 5) A Notice of Appearance (Form D) was entered by the Respondent on 8th March 2019;
- 6) A Defence (Form E) was filed by the Respondent on 14th March 2019;
- 7) This matter was listed for a Case Management hearing set for 29th April 2019 by way of Form J and on 9th April 2019 Notice of the hearing was served on both the Applicant and Respondent;

IT IS HEREBY ORDERED as follows:

1. The Applicant shall file his witness statement(s) and documents in support of his claim and serve the same on the Respondent by no later than 3:30 pm on Monday 27th May 2019;
2. The Respondent shall file its witness statement(s) and supporting documents and shall serve the same on the Applicant by no later than 3:30 pm on Monday 24th June 2019;
3. Each party shall be at liberty to call up to four (4) witnesses;
4. The Applicant shall file and serve his skeleton arguments and authorities and serve the same on the Respondent by no later than 3:30 pm on 22nd July 2019;
5. The Respondent shall file its skeleton arguments and authorities and serve the same on the Applicant by no later than 3:30 pm on 19th August 2019;
6. This matter shall be set down for a mention hearing at 10:00 a.m. on Monday 9th September 2019; and

7. The parties shall have liberty to apply for further directions and/or to vary these directions.
