**ORDER ON DIRECTIONS**

**WHEREAS:**

- 1) By Certificate of Referral of a Trade Dispute dated 19 March 2019, the Minister referred the subject dispute to the Industrial Tribunal;
- 2) Pursuant to Rule 3(1) of the Industrial Relations (Tribunal Procedure) Rules, 2010 a Notice for presentation of an Originating Application was issued by the Secretary of the Industrial Tribunal to the Applicant on 31 May 2019;
- 3) The Applicant filed an Originating Application (Form A) in the Industrial Tribunal on 12 June 2019;
- 4) Pursuant to Rule 4 of the Industrial Relations (Tribunal Procedure) Rules, 2010 a Notice of the Originating Application (Form C) was issued by the Tribunal to the Respondent on 1 October 2019;

- 5) A Notice of Appearance (Form D) was entered by the Respondent on 11 October 2019 and a Defence (Form E) on 23 October 2019;
- 6) This matter was listed for a Case Management hearing on 9 December 2019 which was served on the Applicant on 6 November 2019 and on the Respondent on 31 October 2019.

**IT IS HEREBY ORDERED** as follows:

1. The Applicant and the Respondent shall file their respective Witness Statements and Bundles of Documents and serve the same on each other by no later than Wednesday 15 January 2020;
2. The Applicant and the Respondent shall file any Supplemental Witness Statements and supporting Supplemental Bundles of Documents they deem necessary and shall serve the same on each other by no later than Wednesday 29 January 2020;
3. Each party shall be at liberty to call up to three (3) witnesses;
4. The Applicant and the Respondent shall file and serve their Skeleton Arguments and Authorities by no later than Thursday 13 February 2020; and
5. The parties shall have liberty to apply for further directions and/or to vary these directions.
