**WHEREAS:**

- 1) By Certificate of Referral of a Trade Dispute dated 15 April 2019, the Minister referred the subject dispute to the Industrial Tribunal;
- 2) Pursuant to Rule 3(1) of the Industrial Relations (Tribunal Procedure) Rules, 2010 a Notice for presentation of an Originating Application was issued by the Secretary of the Industrial Tribunal to the Applicant on 27 June 2019;
- 3) The Applicant filed an Originating Application (Form A) in the Industrial Tribunal on 9 July 2019;
- 4) Pursuant to Rule 4 of the Industrial Relations (Tribunal Procedure) Rules, 2010 a Notice of the Originating Application (Form C) was issued by the Tribunal to the Respondent on 16 July 2019;

- 5) A Notice of Appearance (Form D) was entered by the Respondent on 26 July 2019 and a Defence (Form E) on 16 August 2019;
- 6) This matter was listed for a Case Management hearing on 5 November 2019 which was served on the Applicant and on the Respondent on 15 October 2019.

**IT IS HEREBY ORDERED** as follows:

1. The Applicant shall file her Witness Statement and Bundle of Documents and serve the same on the Respondent by no later than Tuesday 26 November 2019;
2. The Respondent shall file its Witness Statement and Bundle of Documents and serve the same on the Applicant by no later than Tuesday 17 December 2019;
3. Each party shall be at liberty to call up to two (2) witnesses at the trial of this matter;
4. The Applicant and the Respondent shall file and serve their respective Skeleton Arguments and Authorities by no later than Monday 20 January 2020; and
5. The parties shall have liberty to apply for further directions and/or to vary these directions.
