ORDER ON DIRECTIONS

WHEREAS:

- 1) By Certificate of Referral of a Trade Dispute dated 11 October 2019, the Minister referred the subject dispute to the Industrial Tribunal;
- 2) Pursuant to Rule 3(1) of the Industrial Relations (Tribunal Procedure) Rules, 2010 a Notice

for presentation of an Originating Application was issued by the Secretary of the Industrial Tribunal to the Applicant on 31 October 2019;

- 3) The Applicant filed an Originating Application (Form A) in the Industrial Tribunal on 25 November 2019;
- 4) Pursuant to Rule 4 of the Industrial Relations (Tribunal Procedure) Rules, 2010 a Notice of the Originating Application (Form C) appears to have been issued by the Tribunal to the Respondent on 28 November 2019, and again more than one year later, on 30 December 2020;
- 5) A Notice of Appearance (Form D) was entered by the Respondent on 5 January 2021 and a Defence (Form E) on 20 January 2021;
- 6) This matter was listed for a Case Management hearing on 25 March 2021 during which Counsel asked that the Tribunal, in the granting of time to file witness statements, consider the number of witnesses to be involved.

IT IS HEREBY ORDERED as follows:

1. The Applicant shall file his Witness Statement(s) and Bundle of Documents and serve the same on the Respondent by no later than Thursday 22 April 2021;
2. The Respondent shall file its Witness Statement(s) and Bundle of Documents and serve the same on the Applicant by no later than Thursday 20 May 2021;
3. Each party shall be at liberty to call up to four (4) witnesses;
4. The Applicant shall file and serve his Skeleton Arguments and Authorities on the Respondent by no later than Thursday 3 June 2021;

5. The Respondent shall file and serve its Skeleton Arguments and Authorities on the Applicant by no later than Thursday 17 June 2021; and
6. The parties shall have liberty to apply for further directions and/or to vary these directions.
