**ORDER**

**WHEREAS:**

1. By Certificate of Referral dated 14<sup>th</sup> May, 2019 the Minister referred the subject dispute to the Industrial Tribunal; and
2. In accordance with Rule 3 (1) of the Industrial Relations (Tribunal Procedure) Rules, 2010 a Notice for an Originating Application- Form A was sent to the Applicant on 31<sup>st</sup> May, 2019 by the Secretary, to the Tribunal; and
3. Upon receipt by the Applicant of the Notice for an Originating Application the Applicant filed an Originating Application on the 19<sup>th</sup> June, 2019; and
4. A Notice of Application to the Respondent- Form C and a Notice of Appearance-Form D were sent to the Respondent on the 2<sup>nd</sup> July, 2019; and
5. That a Notice of Appearance-Form D was filed on 19<sup>th</sup> July, 2019 and a Defence- Form E, was filed in the Tribunal by the Respondent on 7<sup>th</sup> November, 2019; and
6. Pursuant to Rule 15(1) of the Industrial Relations (Tribunal Procedure) Rules 2010, the Industrial Tribunal set a fixture on the 10<sup>th</sup> December, 2019 for the Case Management Hearing for Directions; and
7. The matter was adjourned several times and a fixture date was set for 16<sup>th</sup> July, 2020, Counsel for the Respondent, by letter dated 29<sup>th</sup> June, 2020 withdrew its representation and subsequently advised that the Respondent is no longer in the jurisdiction; and
8. On 29<sup>th</sup> January, 2021, a Notice of Call Over was published in the Nassau Guardian for hearing of the matter on 24<sup>th</sup> March, 2021; and

9. The matter was relisted for Case Management Hearing on 19<sup>th</sup> August, 2021. The Applicant appeared, acknowledged that the Respondent is no longer in the jurisdiction and withdrew her Application and requested that the matter be disposed of.

**IT IS HEREBY ORDERED:**

In view of the above and in accordance with is decided accordingly Rule 12(1) (f) of the Industrial Relations (Tribunal Procedures) Rule 2010, that the Originating Application filed herein on 19<sup>th</sup> June, 2019 is hereby struck out and the matter is dismissed.
