- (1) By Certificate of Referral dated March 24, 2021 the Minister referred the subject dispute to the Industrial Tribunal; and
- (2) In accordance with Rule 3 (1) of the Industrial Relations (Tribunal Procedure) Rules, 2010 a Notice for an Originating Application – Form A was sent on April 15, 2021 by the Secretary, to the Tribunal, to the Applicant; and
- (3) Upon receipt by the Applicant of the Notice for an Originating Application the Applicant filed an Originating Application in the Tribunal on May 5, 2021; and
- (4) A Notice of Application to the Respondent – Form C and a Notice of Appearance - Form D was sent to the Respondent on May 7, 2021; and
- (5) That a Notice of Appearance - Form D was filed on May 25, 2021 and a Defence – Form E was filed on June 15, 2021 in the Tribunal by the Respondent; and
- (6) Pursuant to Rule 15(1) of the Industrial Relations (Tribunal Procedure) Rules 2010, the Industrial Tribunal set a fixture on July 14, 2021 for the Case Management Hearing for Directions; and
- (7) That Mr. Carter appeared on behalf of the Applicant and Ms. Tooté appeared for the Respondent on the date fixed for Case Management; and
- (8) During that time, Mr. Carter requested that the Tribunal consider joining Myers Group of Companies, George Myers in his personal capacity and Luciano's of Chicago to this matter before the Tribunal; and
