WHEREAS:

- (1) By Certificate of Referral dated April 20, 2021 the Minister referred the subject dispute to the Industrial Tribunal; and
- (2) In accordance with Rule 3 (1) of the Industrial Relations (Tribunal Procedure) Rules, 2010 a Notice for an Originating Application – Form A was sent on May 5, 2021 to the Applicant by the Secretary to the Tribunal; and
- (3) Upon receipt by the Applicant of the Notice for an Originating Application the Applicant filed an Originating Application in the Tribunal on May 26, 2021; and
- (4) A Notice of Application to the Respondent – Form C and a Notice of Appearance - Form D was sent to the Respondent on May 28, 2021; and
- (5) That no Notice of Appearance - Form D or Defence – Form E was filed in the Tribunal by the Respondent; and
- (6) Pursuant to Rule 15(1) of the Industrial Relations (Tribunal Procedure) Rules 2010, the Industrial Tribunal set a fixture on November 22, 2021 for the Case Management Hearing for Directions; and
- (7) The matter was also listed for Call Over on November 22, 2021 and Notice for the said hearing was Gazetted in the Tribune Newspaper on October 28, 2021; and
- (8) That Ms. Major appeared for the Applicant and Mr. Rodney Curry appeared for the Respondent on November 22, 2021 for the Case Management Hearing; and
- (9) During that time, the Applicant requested that the Tribunal consider consolidating this matter with NP2021-129 Jewel Brown v Bahamas Elite Sports Academy; and
- (10) The Respondent had no objections to the consolidation of this matter with NP2021-129 Jewel Brown v Bahamas Elite Sports Academy; and
- (11) That Mr. Curry requested an adjournment to allow the Respondent to retain counsel; and

IT IS HEREBY ORDERED by consent of the parties:

- a. That NP2021-129 Jewel Brown v Bahamas Elite Academy be consolidated with NP2021-131 Cora Major v Bahamas Elite Sports Academy to be heard as one matter pursuant to Rule 17(1) of the Industrial Relations (Tribunal Procedures) Rule 2010.
- b. That the Respondent will have four (4) weeks from the date of this Order to retain counsel. The Respondent is to inform the Tribunal of his appointment of counsel.
- c. That this matter is to be relisted on the expiration of four (4) weeks from the date of this Order notwithstanding whether the Respondent has retained counsel.
