WHEREAS:

- (1) By Certificate of Referral dated August 5, 2021 the Minister referred the subject dispute to the Industrial Tribunal; and
- (2) In accordance with Rule 3 (1) of the Industrial Relations (Tribunal Procedure) Rules, 2010 a Notice for an Originating Application – Form A was sent on August 19, 2021 to the Applicant by the Secretary to the Tribunal; and
- (3) Upon receipt by the Applicant of the Notice for an Originating Application the Applicant filed an Originating Application in the Tribunal; and
- (4) A Notice of Application to the Respondent – Form C and a Notice of Appearance - Form D was sent to the Respondent on November 24, 2021; and
- (5) That a Notice of Appearance - Form D was filed in the Tribunal on November 30, 2021 and a Defence –Form E was filed in the Tribunal on December 16, 2021 by the Respondent; and
- (6) Pursuant to Rule 15(1) of the Industrial Relations (Tribunal Procedure) Rules 2010, the Industrial Tribunal set a fixture on April 4, 2022 for the Case Management Hearing for Directions; and
- (7) That Mr. Ferguson appeared for the Applicant and Ms. Cleare appeared for the Respondent for the Case Management Hearing; and
