- (4) A Notice of Application to the Respondent Form C and a Notice of Appearance Form D was sent to the Respondent on September 23, 2021; and
- (5) That a Notice of Appearance Form D was filed in the Tribunal on October 18, 2021 and no Defence –Form E was filed in the Tribunal by the Respondent; and
- (6) Pursuant to Rule 15(1) of the Industrial Relations (Tribunal Procedure) Rules 2010, the Industrial Tribunal set a fixture on April 6, 2022 for the Case Management Hearing for Directions; and
- (7) That Mrs. Smith-Curry appeared for the Applicant and Mr. Edgecombe appeared for the Respondent for the Case Management Hearing; and
- (8) During that Case Management Hearing the Applicant was ordered to provide Further and Better Particulars of the claim; and
- (9) That on April 12, 2022 the Applicant filed Further and Better Particulars in the Tribunal; and
- (10) The Industrial Tribunal set another fixture on July 28, 2022 for a Case Management Hearing for further Directions; and
- (11) On the day of the Case Management Hearing both parties appeared, and further directions were agreed and ordered by the Industrial Tribunal; and
- (12) That the Applicant filed into the Tribunal Notice of Withdrawal Form K on August 22, 2022; and
