- (1) By Certificate of Referral dated August 11, 2022 the Minister referred the subject dispute to the Industrial Tribunal; and
- (2) In accordance with Rule 3 (1) of the Industrial Relations (Tribunal Procedure) Rules, 2010 a Notice for an Originating Application – Form A was sent on September 26, 2022 to the Applicant by the Secretary to the Tribunal; and
- (3) Upon receipt by the Applicant of the Notice for an Originating Application the Applicant filed an Originating Application on October 6, 2022 in the Tribunal; and
- (4) A Notice of Application to the Respondent – Form C and a Notice of Appearance - Form D was sent to the Respondent on October 13, 2022; and
- (5) That a Notice of Appearance - Form D was filed on November 4, 2022 and a Defence – Form E was filed November 22, 2022 in the Tribunal by the Respondent; and

- g. That if there a settlement is agreed the parties will inform the Tribunal immediately and provide the documents proving the settlement.
