WHEREAS:

- (1) By Certificate of Referral dated August 11, 2022 the Minister referred the subject dispute to the Industrial Tribunal; and
- (2) In accordance with Rule 3 (1) of the Industrial Relations (Tribunal Procedure) Rules, 2010 a Notice for an Originating Application – Form A was sent on September 26, 2022 to the Applicant by the Secretary to the Tribunal; and
- (3) Upon receipt by the Applicant of the Notice for an Originating Application the Applicant filed an Originating Application in the Tribunal on October 6, 2022; and
- (4) A Notice of Application to the Respondent – Form C and a Notice of Appearance - Form D was sent to the Respondent on October 13, 2022; and
- (5) That a Notice of Appearance - Form D was filed October 19, 2022 and a Defence – Form E was filed November 1, 2022 in the Tribunal by the Respondent; and
- (6) Pursuant to Rule 15(1) of the Industrial Relations (Tribunal Procedure) Rules 2010, the Industrial Tribunal set a fixture on March 29, 2023 for the Case Management Hearing for Directions; and
- (7) That Mr. McKinney appeared for the Applicant and that Mrs. Major appeared for the Respondent for the Case Management Hearing; and
- (8) The matter was adjourned to March 31, 2023; and
- (9) The parties returned of March 31, 2023 to complete the case management; and

IT IS HEREBY ORDERED by consent of the parties:

- a. That NP2022-109 Camille Dean v Betty K. Agencies be consolidated with NP2022-107 Tameko Shanique Musgrove v Betty K. Agencies to be heard as one matter pursuant to Rule 17(1) of the Industrial Relations (Tribunal Procedures) Rule 2010.
- b. That there will be no settlement pursuant to Section 60 of the Industrial Relations Act.
- c. That the Applicant will file Skeletons Witness Statements and or Submissions on or before April 20, 2023.
- d. That the Respondent will file Skeletons Witness Statements and or Submissions on or before May 12, 2023.
- e. That there will be a mutual exchange of bundles.
- f. That the Respondent is to provide the Applicant with a copy of the handbook and contracts.
- g. That the parties agreed to an estimated two (2) days of hearing.
- h. That the parties agreed that the Applicant will call four (4) witnesses and the Respondent will call three (3) witnesses.
