AND WHEREAS the Respondent failed to file a **Form E** (Defence) within the time limited for so doing by to **Rule 6 of The Rules**;

AND WHEREAS the Tribunal heard the matter in the absence of the Respondent's Representative on the 10th May, 15th June and 26th June, 2023, and set the matter for trial at 10:00 a.m. on Monday, 24th July, 2023;

AND WHEREAS the Applicant today (Thursday, 20th July, 2023) filed a **Form K** (Notice of Withdrawal) in this matter;

IT IS HEREBY ORDERED THAT this matter be dismissed pursuant to **Rule 12(1)(a) of The Rules**.
