- 1) On the 4th September, 2023, Rosheed Pratt ("the Applicant") filed a Report of a Trade Dispute against Fowlco Ltd., T/A Fowlco Marine & Logistics Management ("the Respondent") with The Department of Labour in Grand Bahama, The Bahamas, which stated, that the issues relevant to the dispute were Unfair Dismissal, Wrongful Dismissal, Severance pay, Notice pay, Vacation pay, Wages owed and deductions from wages owed;

- 6) On the 22nd November, 2023, the **Respondent** filed a **Form D** (Notice of Appearance);
- 7) The Respondent failed to file a **Form E** (Defence) within the time limited for so doing by **Rule 6** of **The Rules**;
- 8) The Tribunal served both parties with a **Form J** (Notice of Hearing) setting this matter for **Case Management** hearing at 10:00 a.m. on 21st February, 2024; and
- 9) The Applicant today filed a Form K (Notice of Withdrawal) in this matter;

IT IS HEREBY ORDERED THAT this matter be dismissed pursuant to Rule 12(1)(a) of The Rules.
