- 2.3The witness statements shall stand as evidence in chief at the trial and should any witness not attend, the witness statements will not be accepted as evidence.
- 3. Given the parties already have their proposed documents, the Applicant and the Respondent shall file an agreed Bundle of Documents with two copies to the secretary to Court No. 5 of the Tribunal no later than 4:00 p.m. on 9th February 2024.
- 4. The trial of this matter is set for one day, to be determined by the Registry.
