**WHEREAS:**

1. By Certificate of Referral dated 6<sup>th</sup> December 2023, the Minister referred the subject Trade Dispute to the Industrial Tribunal;
2. The Applicant having failed to Enter Form A Originating Application, and the parties having appeared by way of Call Over, they entered into dialogue pursuant to Section 60 of the Industrial Relations Act, and were able to reach amicable conclusion by means of mediation;
3. Accordingly, and without any admission of liability, the parties have agreed that the Respondent, **TIKI BIKINI HUT JUNKANOO BEACH** shall pay to the Applicant, **JAKEISHA JOHNSON**, the sum of One Thousand, Three Hundred and Forty-Nine Dollars and Eight Cents (\$1,349.08), in full and final settlement of this matter by way of check to be paid on or before Tuesday, 12<sup>th</sup> August 2024;
4. The Applicant, in accepting the terms of settlement in the sum of One Thousand, Three Hundred and Forty Nine Dollars and Eight Cents (\$1349.08) has submitted the **FORM K**, and as a result thereof, accepts and agrees that the Respondent is herewith now and forever **RELEASED** from any and all claims arising from her employment and separation therefrom whatsoever and howsoever arising, and herewith confirms, to remove all doubt, that there remains no matter outstanding between the parties, as touching the instant action;
5. The parties further agree to retain full confidentiality with the terms of this Settlement and shall altogether resist and forbear from disparaging comments made with respect to each other;
6. Accordingly, this matter now stands dismissed, by way of this **ORDER OF SETTLEMENT**.
