WHEREAS:

- 1. By Certificate of Referral dated 20th August 2023, the Minister referred the subject Trade Dispute to the Industrial Tribunal; and
- 2. The Applicant filed in the Industrial Tribunal an Originating Application (Form A) on the 2nd October 2023; and
- 3. Notwithstanding the Respondent being duly served the Forms C and D with a copy of the Form A, the Respondent has failed to enter its Appearance and its Defence;
- 4. Pursuant to Rule 15 (1) of the Industrial Relations (Tribunal Procedure) Rules 2010, the Industrial Tribunal conducted a Case Management Hearing for directions today, on the $5^{\rm th}$ July 2024, and
- 5. The Respondent, through its Counsel, has requested leave to enter its Appearance and Defence:

IT IS HEREBY ORDERED, BY CONSENT, as follows:

- 1. The Respondent shall file its Form D and its Form E within 14 days hereof, i.e., on or before 22nd July 2024.
- 2. The trial of this matter shall be set down for 3 days;
- 3. The Applicants have indicated that they intend to call up to seven witnesses and the Respondent has indicated that it intends to call up to three witnesses.
- 4. Inspection of documents, if required, shall take place on or before 26th July 2024 with an agreed bundle of documents to be presented on or before 2nd August 2024.
 - 4.1 The Applicants shall file their Witness Statements and Skeleton Arguments no later than **4:00 p.m.** on 16th of August 2024 and the Respondent shall file its Witness Statements and Skeleton Arguments no later than **4:00 p.m.** on 30th August 2024 and, upon filing, the Applicant and the Respondent shall provide a hard copy of each to the Secretary to Court No. 5 and a copy of which

shall be retained for the Court's use. Should the parties have their witnesses appear in person, a second hard copy of all documents to be relied upon at the hearing hereof, shall be presented to the secretary to Court No. 5.

- 4.2 The witness statements shall stand as evidence in chief at the trial and should any witness not attend, the witness statements will not be accepted as evidence.
- 5. The date of the hearing of this matter shall be determined by the Registry.
- 6. This matter wis set for mention for 10 am on July 31st 2024 for the parties to speak towards possible resolution.
