The Applicant shall file his Witness Statements and Skeleton Arguments no later than 4:00 p.m. on 6th December 2024 and the Respondent shall file its Witness Statements and Skeleton Arguments no later than 4:00 p.m. on 3rd January 2025 and, upon filing, the Applicant and the Respondent shall provide a hard copy of each to the Secretary to Court No. 5 and a copy of which shall be retained for the Court's use. Should the parties have their witnesses appear in person, a second hard copy of all documents to be relied upon at the hearing hereof, shall be presented to the secretary to Court No. 5.
- e. The witness statements shall stand as evidence in chief at the trial and should any witness not attend, the witness statements will not be accepted as evidence.

f. The date of hearing of this matter shall be determined by the Registry.
