WHEREAS:

- 1) By Certificate of Referral dated February 13th, 2024, the Minister referred the subject dispute to the Industrial Tribunal; and
- 2) The Applicant filed in the Industrial Tribunal an Originating Application (Form A) on 11th April 2024; and
- 3) The Respondent, on the 24th June 2024, having been served the Forms C and D, has been granted Leave to enter its Appearance and its Defence forthwith, to be filed on or before 15th November 2024;
- 4) Pursuant to rule 15(1) of the Industrial Relations (Tribunal Procedure) Rules, 2010 the Industrial Tribunal set this matter down for Case Management Hearing on Monday 11th November 2024;

IT IS HEREBY ORDERED, BY CONSENT, as follows:

- a. The trial of this matter shall be set down for 2 days;
- b. The Applicant has indicated that she intends to call up to witnesses and the Respondent has indicated that it intends to call up to witnesses.
- c. Inspection of documents – to take place on or before 15th November 2024 with an agreed bundle of documents to be presented on or before 22nd November 2024.
- d. The Applicant shall file her Witness Statements and Skeleton Arguments no later than **4:00 p.m.** on 6th December 2024 and the Respondent shall file its Witness Statements and Skeleton Arguments no later than **4:00 p.m.** on 3rd January 2024 and, upon filing, the Applicant and the Respondent shall provide a hard copy of each to the Secretary to Court No. 5 and a copy of which shall be retained for the Court's use. Should the parties have their witnesses appear in person, a second hard copy of all documents to be relied upon at the hearing hereof, shall be presented to the secretary to Court No. 5.

- e. The witness statements shall stand as evidence in chief at the trial and should any witness not attend, the witness statements will not be accepted as evidence.
- f. The date of hearing of this matter shall be determined by the Registry.
